El Paso International Airport (EPIA)

ECM has had an ongoing working relationship with the EPIA for more than 25 years. We have managed multiple vertical and horizontal projects, including the \$60 million Terminal Renovation and Expansion, the \$37 million Consolidated Rental Agency Complex (ConRAC) project, the new Checked Baggage Inspection System, and multiple taxiway, runway, and connector projects.



El Paso Water (EPW)

ECM has led multiple project and construction management efforts for EPW throughout the city since 2006 starting with the stormwater program to improve stormwater infrastructure for the region. ECM's work with EPW has included multiple water, wastewater, and stormwater projects, along with wastewater facilities, and multiple administrative and maintenance facilities.



Sun Metro Transit Program

In the last decade, ECM has managed multiple projects for Sun Metro, the City of El Paso's Mass Transit Department. These projects include four transit terminals, multiple Rapid Transit Systems throughout the city, the El Paso Streetcar Project, and the \$29 million Training and Operations Center.



El Paso Electric (EPE)

ECM currently manages a high volume of EPE's capital projects. These projects include new substations, transmission lines and distribution facilities as well as upgrades to existing substation and transmission infrastructure. As a testament to our ability to deliver value for our clients, our EPEC program continues to grow.



El Paso Community College (EPCC)

ECM was the program manager for the \$125 million Master Plan 2016 Bond Program, which included six construction projects over EPCC's five campuses spread all over El Paso County. The projects featured multiple classroom and laboratory new constructions and additions, but the program also included the \$37 million Career and Technical Education Building and Garage facility.

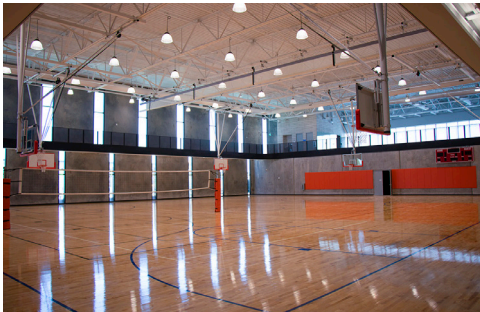

Beast Urban Park

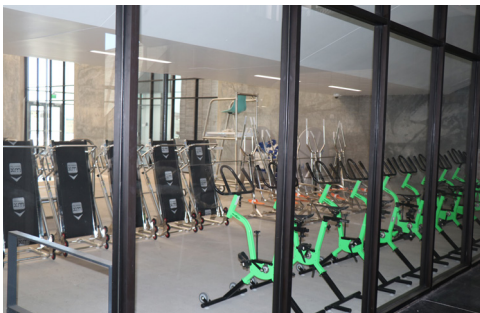
The \$59 million Beast Urban Park is one of the marquee projects of the \$470 million Quality of Life Bond passed by the citizens of the City of El Paso. The park first phase of the park features a 50-meter competition pool, outdoor Aquatic Recreation pool with splash pads, lazy river, tube slides, and a multi-generational recreation center. Future inclusions could include an amphitheater, lighted baseball, football and soccer fields, a skateboard/bike park, dog park, sand volleyball, handball courts, landscaped open areas, and running and nature trails.



ECM managed the design effort of Phase 1, has conducted stakeholders' meetings and scope confirmation meetings, has hosted public outreach meetings and made presentations to City Council and to the Design Review Board. ECM also has verified the architect's preliminary opinion of probable construction cost and has updated the program schedule as well as the program overall budget accordingly.



In order to manage the information generated in such complex program, ECM has set up web-based program management software that provides password-protected real-time access to all the project files.
