Public Safety Bond Program

The \$106 million, multi-faceted program includes the Public Safety Facility, Law Enforcement Center, Jail renovation and expansion, and vehicle maintenance facility and warehouse. As program manager, ECM led the project development, bond planning, design and construction management of all facilities simultaneously for Hays County.



Public Safety Operations and Training Center

At \$27.5 Million and 76,000 SF, this facility is a model for fire and police departments and emergency services alike. Its administrative, training, and conference capabilities are available to local and state entities. ECM was engaged to perform a project status assessment, project execution plan, contract compliance, construction, schedule, Total Project budget, implement a change management system and report directly to Council.



Beast Urban Park

ECM managed the development of the Beast Urban Park for the City of El Paso. This multi-year, three phase program involves a 92-acre site and will become the largest public park in the area. The program includes: a recreational center, competition-ready indoor 50-meter pool, a recreational pool, splash pad, sports fields and necessary infrastructure.



Sun Metro Transit Program

In the last decade, ECM has managed multiple projects for Sun Metro, the City of El Paso's Mass Transit Department. These projects include four transit terminals, multiple Rapid Transit Systems, the El Paso Streetcar Project, and the Bicentennial Council Transit and Operations Center. ECM continues to assist Sun Metro as the city continues to grow.



Fire Station No. 3

The Las Cruces Fire Station No. 3 replaced the existing 50-year-old fire station and can house up to ten fire-fighters at a time, provide space for three large fire trucks, including a ladder truck, and has an outdoor training courtyard, a fitness room, and a training tower. ECM has worked closely with the design team and the Deputy Chief, Battalion Chief, and fire-fighters to meet the specific needs of this station's location.

Featured Government Project



Capitol Complex, Phase 1

The Capitol Complex Project is a transformational program to renovate and update significant portions of downtown Austin. The \$580 million first phase included two new state office buildings, three blocks of the “Texas Mall” promenade with pedestrian friendly greenspace as well as utilities and a five-level below-ground parking.



Phase 1 of the program was divided into six packages each with an individual Architect or Engineer of Record (AOR/EOR) and a Construction Manager at Risk (CMR). ECM served as owner’s representative and project manager on the excavation, utilities, central utility plant, and the Texas Mall and underground parking garage packages.



ECM was part of the construction manager agent team. The firm’s management responsibilities included coordination with the AORs/EORs, CMRs, the City of Austin and multiple State Agencies along with providing input on design documents, pay applications, field changes, budget cost reduction concepts.
