## El Paso Streetcar Trolley

As part of the Quality Assurance (QA) Team on the Streetcar Trolley project, ECM provided third party inspections and managed the quality assurance program for the 4.8 mile long project. The project, managed by the Camino Real Regional Mobility Authority and funded by Texas Department of Transportation, runs through the heavily congested, urban areas of Downtown El Paso to the University of Texas at El Paso (UTEP) campus.



## RM 652 Full Depth Roadway Rehabilitation

ECM was selected to provide CEI services for TxDOT's rural RM 652 Full Depth Pavement Rehabilitation Project; a 7-mile long project in Culberson County, Texas. The RM 652 project was designed to accommodate and sustain the increased volume of heavy load traffic resulting from the oil industry growth in the west Texas region.



## Interstate IH10 Airway Aesthetics

The high-profile, award-winning project consisted of a series of artistic and functional wind sculptures at the Interstate-10 and Airway Boulevard interchange. ECM provided project management, utility coordination, procurement, inspection services and coordinated efforts with the Texas Department of Transportation and the Camino Real Regional Mobility Authority.



## Taxiway Reconstruction and Geometry

ECM was the construction manager for the \$20 million taxiway reconstruction and radius geometries realignment for the El Paso International Airport. ECM successfully orchestrated the work with all agencies at the airport and managed and inspected contractor activities with both EPIA and FAA personnel. ECM has more than 25 years assisting EPIA.



## US 67/90 Roadway Rehabilitation

The project consisted of roadway and bridge improvements for a 9-mile roadway section in Alpine, Texas. The project included full-depth reclamation, cement treatment, bridge reinforcement & concrete slabs, retaining walls, and abutments. ECM supported the inspection and material testing, and we also documented work activities in accordance with TxDOT requirements.

## IH10/Loop 375 Americas Interchange

ECM managed the coordination of all utility relocation from design through construction on this landmark El Paso project. In addition, we provided inspections on retaining walls, drainage, roadways, and utility lines. As the contract administrator, ECM had oversight of the design-builder's compliance with contract requirements and documentation.

Project highlights included:

- \$146 million intersection of Loop 375 at I-10 in East El Paso
- Provided oversight from design through construction
- Three direct connectors to I-10
- Complicated four level, fully directional interchange
